NOTICE OF CONSTITUTIONAL QUESTION

TAKE NOTICE THAT a Statement of Claim has been commenced against the ATTORNEY GENERAL OF MANITOBA, which includes a question about the constitutional validity of the treatment and discrimination of the Plaintiff by representatives of the Attorney General of Manitoba and whether said treatment and discrimination violated the rights of the Plaintiff under sections 2(a), 7, 8 and/or 12 of the *Canadian Charter of Rights and Freedoms, Part I of the Constitution Act, 1982*, being Schedule B to the *Canada Act 1982, (U.K.), 1982, c. 11* (the "Charter"), specifically being:

- i) the fundamental right to freedom of conscience;
 - ii) the right to life, liberty and security of the person;
 - iii) the right to not be subjected to unreasonable search and
 - iv) the right not to be subject to cruel and unusual punishment;
- (hereinafter collectively the "Violations")

and that the said Violations were not a reasonable limit on the Plaintiff's rights under section 1 of the Charter, particulars of which are contained in the Statement of Claim, which is being served concurrently with this Notice of Constitutional Question.
